LETTER OF INTENT TO FILE LAWSUIT FOR WRIT OF MANDAMUS

I am writing to formally notify the Ohio Manufactured Homes Program (MHP), a division of the Ohio Department of Commerce, of my intent to file a petition for a writ of mandamus in the Ohio Supreme Court. This action is being considered due to the MHP's failure to perform it's statutory duties to enforce safe living conditions and hold owners of Poplar Village accountable, as required under Ohio Revised Code Chapter 4781 and related regulations.

Background and Concerns:

As an investigator who has witnessed the conditions at Poplar Village, 12400 W. Axline St., Fostoria, Ohio, I have repeatedly raised concerns regarding unsafe living conditions to the Seneca County General Health District, Judges, and Ohio MHP, including standing raw sewage, still water, mold & bug infestations, & unsafe drinking water. Furthermore, tenants are threatened with eviction if they put their rent into escrow, a direct violation of Ohio Revised Code ORC Section 4781.48. Despite these complaints, agencies including the MHP has failed to take appropriate action to fully investigate or enforce compliance with applicable laws and regulations, including but not limited to Ohio Revised Code § 4781.26 and Ohio Administrative Code § 4781-12. This inaction has resulted in ongoing risks to the health, safety, and well-being of residents.

Legal Basis for Mandamus:

Under Ohio law, a writ of mandamus may be issued to compel a public agency or official to perform a clear legal duty when there is no adequate remedy at law. The MHP has a mandatory duty to enforce the provisions of Ohio Revised Code Chapter 4781, including ensuring that manufactured home park operators maintain safe and compliant living conditions. The failure to act on complaints and enforce these standards constitutes a breach of that duty.

Notice and Opportunity to Cure:

This letter serves as formal notice of my intent to seek judicial relief through a writ of mandamus unless the MHP takes immediate action to address the reported violations and enforce compliance by park owners. I respectfully request that the MHP:

- 1. Conduct a comprehensive investigation of the reported unsafe conditions at Poplar Village, 12400 W Axline St. Fostoria, Ohio.
- Restore safe drinking water to <u>all</u> residents and mandate public access to all internal water testing results.
- 3. Remediate ALL standing raw sewage and still water beneath mobile homes, and ensure park sewer system is 100% operational with no backup.
- 4. Take appropriate enforcement actions against park owners to ensure compliance with Ohio law including Ohio Revised Code ORC Section 4781.48.
- 5. Issue a Cease & Desist to Evergreen Poplar to halt lease-to-own agreements on any mobile home unit without a Title available to transfer after payoff.
- 6. Facilitate Title transfers to mobile home owners with paid off purchase agreements.
- 7. Provide a written response within 30-days detailing the steps taken to address these concerns and/or planned remediation.

Next Steps:

If the MHP fails to act within the specified timeframe or provide a satisfactory response, I intend to file a petition for a writ of mandamus in the Ohio Supreme Court to compel the MHP to fulfill its statutory obligations. I am prepared to seek all available legal remedies, including but not limited to court costs and attorney fees, as permitted by law.
